The event is a weekend of BD/SM play. Equipment is provided and Dungeon Masters will be on hand to assure every one plays safe and has a good time.

Most play is allowed. However due to sanitation, liability and fire concerns, knife play or any instrument with a sharp edge that could open a blood vessel is prohibited, as are scat and fire play. An exception is needle play. A complete list of prohibited play will be in your run packet.

The Run fee is \$45 if registered prior to June 1, 2010 and \$55 there after. Day passes are \$25 and t-shirts are \$15
